10:30 a.m. Sunday, August 1st: SCUUF Sing-a-Long (outside the SCUUF building)

Come join your Fellowship music group for an outside sing-a-long! For COVID caution we will ask that household groups sit 6' apart from each other, however masks will not be required outside. Masks would be required for anyone who enters the building to use the bathrooms. If possible, bring your own camp chairs, but if you don't have a camp chair we will provide chairs as needed. Our sing-a-long will be held in front of the building to keep away from bugs and be accessible to as many people as possible. Please come sing with us and revel in being together and making a joyful noise!!

10:30 a.m. Saturday, August 7th: Walking Meditation (Munsinger Gardens)

There will be a gathering at Munsinger Garden to practice walking meditation. Anyone who would like to come is welcome to join. We will be meeting at the picnic tables in Munsinger Garden. Please note that this is a different meeting location. We're changing the meeting location because the picnic table area is generally less busy than the gazebo area. (If you are facing the river, the picnic table area is a short walk to the left of where the gazebo is.)

Walking meditation is about being fully present with the experience of walking. We will be practicing in a relaxed and light-hearted way. This will also be an opportunity to chat and catch up with each other and enjoy the gardens. We'll have a brief reading at the beginning and a modified version of Joys and Concerns. For the walking meditation part of the gathering, we'll each be walking at our own pace, in whatever way is most comfortable for each of us. If walking is difficult for you, it is totally fine to come and simply sit and rest for part or all of the walking meditation time (about 20 minutes). Children and families are welcome too. You can bring a mask if you'd like (optional), and we will be practicing social distancing for this activity. On Saturday, June 26, a memorial gathering to celebrate the life of Elaine Schrenk took place outside the Fellowship building in the area behind the UU community garden. Elaine was a dedicated member of the Fellowship for the last five years of her life which ended in August 2020. Lucinda Hudson from the Meditation Group and Charlotte Stephens from the Caring Committee led the planning for the gathering in consultation with other Fellowship members and Elaine's sister, Carol. The gathering was attended by about 15 Fellowship members along with more than 20 other friends and family. Since her family and friends who attended are not UUs, we were happy to receive the following note from her sister: "Our heartfelt thanks to all the organizers and readers of Elaine's memorial service. You all did a wonderful job and I can't recall attending a more meaningful and personal service. We received so many lovely compliments about the service from family and friends. It also was special to see Elaine's painting nicely framed and presented at the memorial. I couldn't help but feel Elaine in our midst, so pleased to have the UUF community, friends, and family there to acknowledge her life." The family designated the Fellowship to receive memorial gifts as well as a gift from Elaine's estate, and an accompanying note said, "Thank you for so warmly welcoming Elaine into your spiritual community."

In July, Alan Phillips, a SCUUF member who moved to Minneapolis a few years ago, notified us that his companion of seven years, Eugenia McGrath, passed away at Abbott-Northwestern hospital on July 6. She was 84. Alan also said he plans to move back to St Cloud, perhaps later this year.

MUUSJA Update

For the first time in history the Minnesota UU Social Justice Alliance Board of Directors has more representation from greater Minnesota than from the Metro! In addition to St. Cloud, we have Board members from Duluth, Rochester, and Willmar, and all three of our new Board leaders are from greater MN. I am one of those leaders and I am also the MUUSJA representative to the 8th Principle Learning Community, which meets once a month.

At the first meeting I attended I learned that SCUUF is among 117 congregations listed as having affirmed the 8th Principle. As I understand it, any congregation can call for national approval. That would have to be done this fall for consideration at the 2022 General Assembly. Otherwise, it will come before the national body in 2023. I'm still not clear on how the final language will be determined, but it will happen at the national level. Meanwhile, we are being urged to keep our focus on the intention of the 8th Principle, not the current specific language.

At our most recent MUUSJA Board meeting, we were introduced to the Intercultural Development Inventory, which measures both individual and organizational intercultural competence, moving from a monocultural to an intercultural mindset. This might be something the SCUUF Board could investigate. If the MUUSJA Board and staff decide to take the inventory, I will be able to provide more information.

Meanwhile, in MUUSJA's work

- There has been significant engagement around Line 3 work, leveraging relationships with the indigenous people, northern UU congregations and MUUSJA.
- The antiracism work and dismantling of George Floyd Square has been time consuming and emotional. Stronger connections from churches are needed.
- Immigration work has been centered primarily through the work from 1st Universalist. MUUSJA Director Karen Wills would like to add a 10-hour position for a Southern Regional Organizer who could lead the efforts in immigration and exploitation issues.
