December President's Corner

The holiday season is upon us. From Bodhi Day to Hannukah to Solstice to Christmas, there are many celebrations and holidays that are celebrated in the month of December. I hope whichever holidays you celebrate are full of joy, connection, and peace.

I have several updates from the Board this month. The first is that the UUA General Assembly will be in Portland this summer and will be held from June 22-26, 2022. Individuals can attend in-person or online. If you are interested in attending the General Assembly, in either manner, please let me know of your interest. We have scholarship funds available and the total amount we could provide to interested individuals will depend on how many people are interested. For more information about the schedule and registration costs, please visit www.uua.org/ga.

Our Fellowship received a request to join Sanctuary and Resistance to Injustice (SARI) in calling for an immediate end to immigrant detention in Sherburne County. The Sherburne County Jail contracts with Immigration and Customs Enforcement (ICE), and SARI believes this is inhumane and unjustly targets immigrant communities in Minnesota. They feel the contract implies that Sherburne County residents support the unjust detention and deportation of those detained in Sherburne County in exchange for the financial gain the ICE contract provides Sherburne County. SARI requested that our Fellowship sign our name to the letter being sent to Sherburne County that supports the termination of ICE detentions:

- 1) abandoning all plans to expand or renew the current contract with ICE
- 2) phase out existing contracts and release, not transfer, all currently detained immigrants;
- 3) resolve that Sherburne County will be a Sanctuary County requiring law enforcement to pledge they will no longer collaborate with, or detain individuals on behalf of ICE.

At least twenty-three other organizations have signed on, including Minnesota Unitarian Universalist Social Justice Alliance (MUUSJA). The Board voted unanimously to support this and lend our congregation's support and name to this letter.

The Anti-Racism Workgroup requested support from the Board to pursue a consultant who can assist our congregation with internal review of our documents and governance processes. The Board approved the Anti-Racism workgroup to pursue getting proposals and estimates from consultants on the time and cost this type of project may take. The Board would still be required to vote on the hiring of the consultant and approving the projected use of funds to cover the consultant expenses.

Happy Holidays and Happy New Year! My sincerest hope is that we will be able to gather together again in-person in 2022. I hope you will continue to participate in virtual options to stay connected to each other in our congregation until that time.

Although the amount rounded up for each purchase may be small, it grows through the month and can become a significant donation. Especially as we begin the winter months, any donations for Homeless Helping Homeless give much-needed support for people in our community who are experiencing homelessness.

Winter Holiday Traditions - Consider Chalica

The Holiday season is upon us and, while some may relish in carrying out a plan for a festive time with family and friends, there are many who struggle at this time of the year. Celebrations and the keeping of traditions, no matter what they may be, take planning and energy. There are times when even the best laid plans can result in disappointment or unhealthy exhaustion. Do you faithfully sustain old and cherished traditions, or have you brought new traditions to your winter celebrations that better align with your values and beliefs?

In 2005, out of a wish to have a holiday organized around our Unitarian Universalist Principles, a new Holiday emerged. Chalica is a week-long celebration of our Principles that begins on the first Monday in December. This year that is Monday December 6th and it will end 7 days later on Sunday December 12th.

Each day represents a different Principle and each day's celebration begins by lighting a chalice or candle. Gifts that reflect our 7 principles can be made, bought, verbal, written, acts of care and kindness or perhaps the sharing of a memory with a loved one.

Here are a few examples:

A gift of a peace offering such as inviting someone to dinner, a letter of forgiveness or an apology brings action to our UU principle of "The inherent worth and dignity of every person."

The perfect gift for a "free and responsible search for truth and meaning" could be to teach someone something you know and love, or make arrangements to learn something new from a person you admire.

Serving a meal to community members is an excellent way to express "justice, equity, and compassion" while making time for human connection.

You could host a dinner party to celebrate democracy to highlight our 5th principle "the right of conscious and the use of the democratic process within our congregations and in society at large."

There are endless ways each individual may choose to live out their values celebrating Chalica. If you would like to make Chalica a Holiday tradition in your home we encourage you to explore ideas available through the UUA website surrounding this recently developed UU Holiday celebration.

The following issues have been addressed:

- 1. stopping line 3 and other aspects of climate change
- 2. support of LGBTQ rights
- 3. care for the homeless (housing, food, shelter)
- 4. support of small/medium sized farm operations
- 5. racial justice/environmental justice
- 6. support of markets for locally grown food

Anti-Racism Team Report

We are sorry to report that Jean Keller has resigned from this group, at least temporarily. If anyone is interested in joining us, please let me know (<u>ifoster58@charter.net</u>). As previously reported, we are working with Doug Polley and Charlotte Stephens to review and revise our Constitution to address issues of outdated language, white supremacy culture, and our leadership structure. Mary Ness will join us for our next meeting.

At our last meeting we agreed to recommend revising Articles I and II as follows.

ARTICLE I. Name and Affiliation

The name of this religious society shall be "The St. Cloud Unitarian Universalist Fellowship." This Fellowship shall be a member of the Unitarian Universalist Association and of the Prairie Star District.

ARTICLE II. Purpose

The purpose of this Fellowship is to further the causes of individual freedom of belief; advancing truth; the democratic process in human relations; brotherhood and sisterhood; and a united world fellowship. We support the Unitarian Universalist Association Statement of Principles. We are a welcoming congregation that seeks to be a spiritual home for people of free faith regardless of race, color, gender, affectional or sexual orientation, age, national origin, socioeconomic status, physical or mental ability.

Proposed Revision

Article I:

The name of this religious society shall be "The St. Cloud Unitarian Universalist Fellowship." This Fellowship shall be a member of the Unitarian Universalist Association and of the **MidAmerica Region.**

Article II.

The purpose of this Fellowship is to further the causes of individual freedom of belief; seeking truth; building a beloved community; promoting social and climate justice; supporting diversity, equity, and inclusion in human relations. We support the Unitarian Universalist Association Statement of Principles. We are a welcoming congregation that seeks to be a spiritual home for people of free faith. We value the full range of human diversity, including race, ethnicity, gender, affectional/sexual orientation, gender identity, age, national origin, socioeconomic status, physical/mental ability.

Please note: This revision will entail changing our Welcoming Congregation statement as follows:

(Current) Welcoming Congregation

We are a Unitarian Universalist Welcoming Congregation that seeks to be a spiritual home for people of free faith regardless of race, color, gender, affectional or sexual orientation, age, national origin, socioeconomic status, physical or mental ability.

(Proposed) Welcoming Congregation

We are a welcoming congregation that seeks to be a spiritual home for people of free faith. We value the full range of human diversity, including race, ethnicity, gender, affectional/sexual orientation, gender identity, age, national origin, socioeconomic status, physical/mental ability.
