MUUSJA/8th Principle Report

At its December Board meeting, MUUSJA renewed the contract of Karen Wills as Executive Director. The Board had previously reviewed Karen's work and issued a glowing report.

While much of MUUSJA's focus this fall has been fundraising, in hopes of being able to improve salaries and benefits for our staff, there has been considerable outreach and relationship building. Karen and the staff led services at five MN UU congregations with a sixth scheduled for January. Karen and two Board members participated in the UUA's Organizing School online program. Karen and staff led two Racial Justice Convening Circles, and Karen participated in a panel at CAIR Interfaith Responses to Islamophobia - MN Challenging Islamophobia conference. We continued our work on the IDI (Intercultural Diversity Inventory), and a virtual Annual Meeting was held on Dec. 14. In addition, Karen met with numerous UU congregations and other state action networks. We are also working to update our website.
