#### 10:30 a.m. Sunday, May 8: Environmental Justice: Using the "Dynamic Tension" of Our UU Principles as a Theological Guide - Meleah Houseknecht, UU seminarian

All too often we have treated our commitment to individual dignity and collective liberation as separate from our respect for the interdependent web of existence of which we are a part. In her essay "Ethical Implications of Environmental Justice" Rev. Dr. Sofia Betancourt admonishes us that, "We should not allow our fear or our rightful sense of immense urgency to legitimize addressing centuries of environmental devastation in isolation from centuries of human oppression and despair." What theological guidance do our principles give us for addressing the dual crises of environmental devastation and human oppression if we hold and interpret them together, rather than in isolation?

#### **Two Sundays Outdoors**

from the Program Committee

The last two Sundays in May we will meet outdoors, not at our building and not via Zoom! Here's information about the locations, directions, and background of these gatherings to supplement the descriptions above.

#### May 22. 10:30 am. Lions Park covered shelter in southwest St Cloud.

**Directions**: The address is 4310 Dublin Drive, but the parking lot is on County 137. Go over the Hwy 15 overpass that's southwest of the Fellowship. (There's no way to access the park from Hwy 15.) The park is on the north side of the road, on the opposite side from Bethlehem Lutheran Church. Coming from the west, go east on Waite Park's 7<sup>th</sup> Street from the 4-way stop sign at 2<sup>nd</sup> Avenue. The parking lot is quite small so some may want to park on Dublin Drive or carpool from the Fellowship building.

**Background**: As the Caring Committee began to talk last winter about offering this program, we knew that we wanted to be together in person to share our collective and individual losses that we experienced over the past couple of years and to celebrate the lives of some who have died. With COVID uncertainties, we decided that the best way to be sure that we could meet in person was to be outdoors, so we scheduled for late May and rented a covered park shelter in case of rain.

#### May 29. 12:00 noon or earlier. John and Linda Peck's farm in Rockville.

**Directions from St. Cloud/Waite Park**: Travel west on Hwy 23 for four miles past the I-94 Intersection. Look for two green signs on the right: Rockville Downtown and Broadway Street. Turn right onto Broadway proceeding into Rockville. At the Rockville Gas and Bait station turn right (north) onto Co. Rd. 139. Once over the Sauk River STAY LEFT onto Sauk River Rd. Go past Rockville County Park to 12299 Sauk River Rd. approximately 1 mile west of the bridge.

**Background**: The Fellowship has a long history of ending the program year with a potluck picnic. Many different locations have been used but the favorite in recent years has been Peck's farm. Due to the pandemic this event did not take place the past two years.


For anyone with emergency needs, a wide range of services is available from agencies and organizations in the community. These can be accessed by calling 211 (or 800-543-7709).
