10:30 a.m. Sunday, November 14: A Spirituality of Mediocrity – Rev. Shelley Dugan

Who wants to be *mediocre*? Or perhaps worse, who wants to be seen as mediocre? Ordinary, run-of-the-mill, nothing to write home about. Or even lower than that - second-rate, low-grade, a hack. Some people, ironically, have been told to "work on their perfectionism" - meaning "get worse at being perfect." Letting go of the need for perfectionism is an important aspect of spiritual maturity. Yet, striving for mediocrity is a difficult goal to wrap our heads around. Is there something to being mediocre besides freedom from the tyranny of perfectionism? Together, in perhaps a mediocre sermon, let us explore the spiritual benefits of not being amazing!

10:30 a.m. Sunday, November 21: Defending Democracy – Marlene Haider, League of Women Voters

Our UU Principles include "the right of conscience and the use of the democratic process within our congregations and in society at large." This presentation will address Voting Rights and the Redistricting process that's required following the 2020 Census. We'll learn about the Freedom to Vote Act and hear about concerns with redistricting including gerrymandering, communities of interest, packing and cracking, etc. What is involved with local redistricting and how can you participate?

10:30 a.m. Sunday, November 28: UU Holidays: Chalica? Luminescence?

November President's Corner

November is somehow already here. The weather has started to turn, and it reminds us that winter will soon be upon us. A reminder to everyone that November 7th is the end of Daylight Savings time. Don't forget to turn your clocks back an hour so you can join our services on time! This is especially important as November 7th will be the second in our three-part Anniversary Celebrations series. We encourage all current and past members to attend if possible. There is not a lot of new news to impart this month from the Board. Our financial stability is still sound, and we appreciate everyone's continued commitment to the financial support of the Fellowship. To the many volunteers that it takes to continue to run our operations and our online presence for Sunday services, you are greatly appreciated! Maybe you've heard this joke, "How many Unitarian Universalists does it take to run a virtual service? Everyone, we're all a part of an interdependent (world wide www.) web of existence". Ok, bad jokes aside, I am amazed at our ability to remain connected even after a year and a half of virtual engagement. Like you, I look forward to the time when we can all connect again in person for Sunday Services.

If you are in need of attending in-person at this time due to technology or other needs, please remember to connect with Tom Hergert. Tom and Jim are working diligently on technology to support these in-person needs, but they may not be available every Sunday to offer this option, so we don't recommend just showing up at the Fellowship building for a Sunday service.

We are currently at 80.71 cases per 10,000 in Stearns County. This is a slight decrease so hopefully this means a potential turn for the better. We are looking for the case count to come down to 30 cases per 10,000 before we can return fully to the building for in-person services. A reminder that booster shots have been approved for 65+ or individuals younger than 65 with certain pre-existing conditions or high-risk contact, and it appears the FDA has approved vaccination for our 5-11 year old age group. There are many locations you can receive a vaccination if you need one. CentraCare offers a walk-in COVID-19 Pfizer and Moderna vaccination clinic that is available from 8am-7pm on Mondays, Tuesdays, and Fridays at CentraCare South Point location for the community ages 12+. That may change as I am writing this on the day that the 5-11-year old group was approved. Call CentraCare Connect at 320-200-3200 for the latest information on availability of boosters or to check whether you need an appointment.

Anti-Racism Team Report

As we continue to work on applying the 8th Principle to our Fellowship work, the Board recently approved a recommendation from the Anti-Racism Team that we separate the internal work of reviewing our governing documents, practices, and policies from our outreach and action work. Anti-Racism would address the internal work and the Social Justice Committee would focus on the external work. Social Justice accepted this recommendation at its last meeting and will begin developing goals and strategies at its next meeting.

Anti-Racism has recruited a couple of SCUUF members to work with us on this project, Doug Polley and Charlotte Stephens. We met recently and decided to start with our SCUUF Constitution. The first thing we noticed was that the Purpose statement at the beginning of the Constitution is out-of-date in both language and content. It reads as follows:

"The purpose of this Fellowship is to further the causes of: individual freedom of belief; advancing truth; the democratic process in human relations; brotherhood and sisterhood; and a united world fellowship. We support the Unitarian Universalist Association Statement of Principles. We are a welcoming congregation that seeks to be a spiritual home for people of free faith regardless of race, color, gender, affectional or sexual orientation, age, national origin, socioeconomic status, physical or mental ability."

The language of "brotherhood and sisterhood" is out-of-date. It includes our welcoming congregation statement, which is anti-discriminatory, but does not include gender identity, and the statement as a whole does not speak to social and climate justice, or what is known as DEI (Diversity, Equity, and Inclusion). Each of us is going to work on a revised statement that is more in line with the recently approved 8th Principle and try to come up with an agreed-upon recommendation for changing this statement. We hope to provide opportunities for Fellowship feedback before making a final recommendation to the Board, which would come before the membership at our Annual Meeting next May. Please be on the look-out for these opportunities, and if you have any other ideas for improving the statement or if you want to work with us on this project, please let us know.

8th Principle/MUUSJA Report

The most recent meeting of the 8th Principle Learning Community provided examples from numerous UU congregations nationwide on changes they have made to policies and practices in light of the 8th Principle. I have saved multiple documents and websites shared by these congregations that could be useful to the Anti-Racism Team as it pursues its work (see Anti-Racism Team Report).

I was struck that All Souls UU Church in Washington D.C. is working with Laura Parks at Unity Unitarian in St. Paul as a consultant. Laura Parks is consulting with the MUUSJA (MN UU Social Justice Alliance) Board members taking the IDI (Intercultural Diversity Inventory). She could be a resource for our Anti-Racism Team.

Another point that came up, though discussion was deferred to another meeting, was Robert's Rules of Order. Numerous attendees expressed their disapproval of this method of making decisions, which is something that will surely come up as the Anti-Racism team reviews our system of governance and decision-making.

Meanwhile, MUUSJA is meeting with Laura Parks in November for a Board assessment on the IDI and is gearing up for end-of-the year fundraising. Keep an eye out for Give to the Max on Nov. 18. Early giving begins Nov. 1 https://www.givemn.org/organization/Muusja
