Annual Treasurer's Report and Pledge Request

Despite the continued challenges of the ongoing pandemic our financial situation is sound. Many of you have contributed your time and treasure to sustain us during this year, and we are very grateful. During this second year of online services our pledge income has decreased somewhat, and our expenses have increased, but remain relatively low due to mostly online programming.

The chart below shows how the current 2021-2022 fiscal year compares to its predecessor in 2020-2021. The amounts shown are actual income received and expenses paid from **July 1 through April 30 of each year**.

Expenses	\$22,482	\$24,482	+\$2,001	+8.90%

Our checking account and certificates of deposit are at US Bank. In addition, we have an investment account at Vanguard. As we move forward into the next fellowship year, we are projecting a modest decline in our income and are expecting some increases in spending due to inflationary costs particularly with insurance premiums.

We are hopeful that we will be prepared to continue a measured reopening with a hybrid model for services during the next year. Accordingly, we ask that you make a pledge for the upcoming year that will sustain and revitalize us as we return to a semblance of normalcy.
